## Directions

- 1 Mix all dry ingredients
- 2 Mix dry blend into water whilst stirring
- 3 Melt fat, add colour and flavour and stir fat mixture slowly into water mixture
- 4 Heat over 80 °C (176 °F) for 5 min and stir properly
- 5 Pour non-dairy cheese mixture into desired form and let cool until hardened
